## Investing in RHC’s Frontline Health Care Professionals



The Ann T. Kadzielski Memorial Fund has been helping Regina Health Center’s frontline health care professionals advance their skills and careers through continuing education for 20 years. Mark Kadzielski and his sister Lucia (who passed away in 2019) established the fund after their mother Ann passed away in 2000. Ann was a resident at Regina Health Center (RHC). Mark said he and his sister really appreciated the quality and compassion of the staff and how they took care of his mother.

“Our intention has always been to have a lasting fund in the memory of our mother that invests in quality staff, which Regina has, and directing the funds for education and skill development,” said Mark.

Care Coordinator Natalie Truelson, LPN, is one of those frontline professionals who is benefitting from the generosity of the Ann T. Kadzielski Memorial Fund. Natalie has worked at Regina Health Center since 2012. She started as a float nurse before being promoted to care coordinator and weekend supervisor.

Natalie’s mother was a nurse, which inspired her to become a licensed practical nurse (LPN) after her two children went to elementary school. She said heartfelt conversations with her mother guided her dream to first receive her LPN and then work on becoming a registered nurse (RN) before finally earning her Bachelor of Science in Nursing (BSN). The memorial fund is helping make that dream become a reality.

## HOPE THROUGH ENDURANCE

A LETTER FROM THE EXECUTIVE DIRECTOR

When reflecting on the journey over the last seven months, it can be easy to focus on the negative—the disruptions to everyday life, the effects of isolation, lost jobs, illness and lost lives. There certainly has been a torrent of negative news and it can be difficult to see an end to this unprecedented journey, but as we read in Romans 5; 3-5, in those sufferings, there is hope.

During these trying times, resident care continues to be our number one priority. We have vigilantly followed all Ohio Department of Health (ODH) guidelines to keep residents, caregivers and staff safe and healthy. We are blessed to have been free from COVID-19 infections throughout this time.

But, this has not come without sacrifice and suffering, as our residents and their loved ones had to turn to phone calls and FaceTime technology to stay connected. It wasn’t until August 11 that we were allowed to begin outdoor visitations—almost a full five months since residents and their loved ones had been allowed to see each other in person. Now, the state is also allowing indoor visitation, just in time for colder weather. These visits must still be scheduled in advance and a number of stringent rules apply to keep everyone safe. We have the luxury of having a good deal of physical space here so these in-person visits can safely happen.

Our residents have been absolutely gracious in understanding the need to protect everyone. We are grateful to our residents and their loved ones for making so many sacrifices during this difficult, ongoing pandemic, and are thrilled that they can once again see each other in person.

An important aspect of life at Regina Health Center and of helping improve residents’ overall health is spirituality. With residents unable to be physically present in our chapel, Pastoral Care Director Mary Takacs did a great job adjusting and finding ways to keep residents connected spiritually, including upgrading technology to offer more religious programming in resident rooms. You can read more about these efforts on page 3.

Despite the pandemic, we were able to hold our annual Holy-In-One Golf Outing in August with all activities outside and social distancing in place. We raised just as much money as last year with fewer golfers than normal. This was an incredible feat and is due to the heroic efforts of our staff and volunteers, and the continued generosity of our donors and sponsors.

For me, these trying times remind me that I am extremely proud to lead Regina Health Center and work with so many amazing people who care so much about our residents. I thank everyone—residents, caregivers, staff, supporters and families—for showing great character these past several months and for remaining hopeful for the coming months.

## Spiritual Enrichment Continues in New Ways during the Pandemic

Spiritual care is an important part of life at Regina Health Center (RHC) and its faith-based environment. The COVID-19 pandemic temporarily upended spiritual events and activities, but the pastoral care department was able to quickly pivot to continue providing spiritual enrichment activities to residents.

Before March 18, residents could attend daily Mass, common prayer, and other religious and sacramental celebrations in the chapel, with communion being brought to residents not in the chapel. Coronavirus quickly changed all of that.

While Mass was not able to be held in the chapel from March 18 to May 30 because of the pandemic, the pastoral care department ensured residents could listen to audio of daily mass from local parishes over RHC's chapel channel (channel 9), as well as daily rosary. Residents could also watch religious programming on EWTN, the global Catholic TV network.

Starting Pentecost Sunday (May 31), weekly Mass was again held in the RHC chapel with resident and visiting priests presiding and residents able to watch from their rooms on the chapel channel. There have also been multiple prayer services in the chapel with a few residents attending and others able to watch from their rooms. Daily Mass in the chapel and communion returned September 14, with residents able to watch from their rooms and communion distributed to their rooms.

Through Formed.org, the pastoral care department has also been offering bible studies, spiritual programming and movies about saints that residents can watch in their rooms. Starting October 14, residents were able to again attend Mass in the chapel.

## Sisters of Charity of St. Augustine Prepare to Celebrate 170 Years of Charity

“Surely I can do this for God,” reasoned the young woman who would grow to become Sr. Augustine Brulois, one of the founding members of the Sisters of Charity of St. Augustine (CSA). At the request of Bishop Rappe, the first bishop of Cleveland, she, along with another postulant and two professed Sisters, made the journey to Ohio in 1851. Now, almost two centuries later, CSA will celebrate its 170th anniversary in 2021.

Despite unfamiliar language, a historically severe winter and the two professed Sisters returning to

France, the two postulants persevered. CSA opened St. Joseph Hospital in 1852, the first Catholic hospital in Cleveland. CSA's ministry has grown to include health care, education and social services. The sisters established St. Vincent Orphanage in 1856, St. Vincent Charity Hospital in 1865, St. Augustine Academy in 1925, and Providence Hospital, South Carolina in 1937—to name only a few.

Throughout decades of change and uncertainty, CSA has remained true to its charism, "In all things charity." The sisters have continued to adapt to new needs. The CSA Sisters were there in 1918, providing treatment, comfort and hope during the flu pandemic and continue to do the same during the COVID-19 pandemic. Charity Hospital has grown to become St. Vincent Charity Medical Center; Saint Ann Hospital and its subsequent foundation have become the Sisters of Charity Foundation. In 1993, CSA opened its motherhouse at Mt. Augustine to those in need of care, establishing Regina Health Center in the same building.

The Sisters of Charity of St. Augustine, its associates and co-ministers continue to live its call to prayer, community life and service to God's people into the next decade "In All Things Charity." ♦

## Tips for Year-End Planning that Can Benefit Both You and Regina Health Center

Thanks to you, our generous donors, Regina Health Center is able to provide exceptional, compassionate care to those who need it most in a beautiful, comfortable home. The following are some points to consider as you plan your end-of-year giving.

### IRA Charitable Rollover Gift

If you are 70½ years of age or older, you can support Regina Health Center through distributions from your Individual Retirement Account (IRA). Your IRA Charitable Rollover Gift may satisfy your annual required minimum distribution and reduce your taxable income. (Note: required minimum distributions from IRAs and pension plans for donors over the age of 70½ are suspended for 2020.)

### CARES Act Giving Incentives

The Coronavirus Aid, Relief, and Economic Security (CARES) Act provides new, significant giving incentives, including:

- Donors can deduct cash donations up to 100% of their adjusted gross income (AGI) for 2020.
- In 2020 and future years, taxpayers can claim a \$300 (\$600 for a married couple) “above the line” deduction for cash donations to charities.
- The gifts apply to cash gifts only. Stock gifts remain limited to 30% of AGI and are not deductible above the AGI line.

The CARES Act has led to the temporary suspension of the requirements for required minimum distributions for the 2020 tax year. Consult your financial advisor for the most advantageous opportunities for you.

### Gifts of Stock

You may also consider donating gifts of stock. Depending on the stock’s current value, you may avoid capital gains tax or deduct the loss in value while donating the proceeds of the sale to Regina Health Center. Consult your financial advisor for the most advantageous opportunities for you.

### Bequests

Creating a bequest is one of the most popular options for legacy giving. With the help of a lawyer, you can designate which charities or nonprofits are included in your will. This can be done a number of ways:

- **Percent bequest** – where a certain percent of your estate will/can be donated
- **Specific bequest** – where a certain dollar amount is gifted
- **Residual bequest** – where a gift is made from the balance of your estate.

Bequests are ideal for donors who want to split their estate between family, friends and their favorite charitable nonprofits. You can also designate that your bequest be spread out across several years, so the money isn’t spent all at once.

Natalie is now enrolled in the University of Akron LPN to BSN program and expects to earn her bachelor's degree in 2023. The fund covers the cost of tuition, books and medical supplies, as well as contributing to commuting expenses due to living off campus.

"I am very appreciative to Mr. Kadzielski and Regina Health Center for the nursing education financial support. I hope to stay here for the duration of my nursing career," said Natalie. "The spirituality of the residents and staff provide a peaceful, relaxing and welcoming work environment. It is truly a family feeling."

**Attracting and retaining talented nurses and other caregivers has become more challenging in light of the pandemic. Being able to offer opportunities for advancing education is an important recruitment and retention tool.**

"The Ann T. Kadzielski Memorial Fund is helping us invest in our employees by helping them expand their skills through continuing education," said Mark Yantek, executive director, Regina Health Center. "Not only does providing education money to frontline health professionals expand their skills, it's one more incentive for our staff to stay here because they know we're willing to invest in helping them grow."

Although he lives in California, Mark continues to make donations to the fund he and his sister started in 2000 to keep expanding its impact on RHC's frontline workers. Mark grew up on Cleveland's West Side and graduated from St. Ignatius High School and then John Carroll University. He attended Penn Law School and earned his law degree in 1976. Preferring warmer climates, he headed to California, passed the bar exam and joined a health care law firm at a time when that legal specialty was in its infancy. He is now a partner


## Welcome New Director of Fiscal Services James Karasek
